Aim of the course	The course enables students to develop a body of work, investigating a strong underlying visual idea in drawing that grows out of a coherent plan of action or investigation. Students develop their creative, collaborative and drawing skills.
Prerequisites	Completion of the second year of studies
Learning outcomes:	
– knowledge	 The student deepens their knowledge of drawing techniques and methods The students expands their knowledge of contemporary drawing practices
— skills	 The student can develop original and creative interpretations of nature The student can create and develop a coherent artwork, exploring his/her own visual language
– personal and social competence	 The student is able to formulate opinions and judgements about their own works, as well as the works of other artists The student takes an active interest in culture, as well as the cultural life and activities taking place in the academy and in the studio
Course content	Students creatively apply their knowledge and skills to produce their artworks. They consider multiple perspectives in drawing, analyse its limitations, see the difference between tradi- tional and modern drawing. The course teaches students a variety of concepts and approaches in drawing so that the student is able to demonstrate a wide range of abilities and versatility as far as technique, problem-solving, and ideation are concerned.
