Learning outcomes:	
– knowledge	The student has: - artistic awareness, - the knowledge of current artistic trends and their relationship with painting, - the awareness of the richness of phenomena and trends in contemporary art and culture, - the broadly-understood awareness of contemporary world issues and current social phenomena.
– skills	The student: - professionally executes their works, - develops an individual artistic language allowing for a variety of relationships with other disciplines: spatial installation, video, photography etc., - makes independent artistic decisions, - formulates artistic concepts and comments on these concepts and student's own work.
– personal and social competence	The student: - has good verbal communication skills, - works well in a team, - organizes their individual work and presents it publicly, - is sensitive to all the phenomena concerning nature, civilization and culture.
Course content	Further development of the student's artistic program depending on students' individual predispositions Choosing students' own topics and ways of realising them creatively and individually
