Aim of the course	Students deepen their knowledge of drawing techniques and methods of work. Students learn to consciously choose their means of expression, including the use of light and shadow and various drawing tools (coal, brush).
Prerequisites	Completion of the first year of studies Ability to apply the acquired knowledge to continue the educational process Openness to the diversity of artistic phenomena Willingness to pursue and develop cognitive and artistic creativity
Learning outcomes:	
– knowledge	- The student acquires the knowledge of the methods of work for the analysis of an object - The student deepens their knowledge of drawing techniques and methods - The student increases their awareness of the diversity of stylistic means
– skills	- The student attempts to create their own artistic language based on the study of nature.
– personal and social competence	- The student is able to formulate opinions and judgements about their own work, as well as the works of other artists - The student can recognize various contexts and relationships in drawing
Course content	Methods for constructing shapes in space - capturing the characteristics of the object.  Methods for differentiation of matter - capturing the characteristics and properties of the object.  Stylistic devices in drawing.  Deepening students' knowledge of drawing techniques - including mixed techniques.  Analysis of formal and ideological realization of drawing.  Drawing in the context of contemporary art.
Course form and number of course hours	8 hours/week Classes are held in the studio, in the form of practical tasks, individual working critiques, and individual or team projects.
Assessment methods and criteria	The final grade is based on students' attendance, reviews of works and students' own work.  1. students' work in the studio - 60%  2. students' own work - 40%
