Aim of the course	Learning the language grammatical structure drawing. The acquisition of the ability to use basic drawing techniques and working methods. Solving drawing by analyzing the objects and figures.

Course <b>content</b>	Structural drawing grammar categories. Issues concerning the construction of spatial block. Types of perspective and its application in the drawing. Chiaroscuro modeling - working methods. Value and chiaroscuro - analysis on the example of studio work. Study Model: the dynamics of the form, characteristics of the model, Optical shortcuts. Anatomy of the form - analysis of the examples of studies in the model. Application of basic drawing techniques and working methods.
Course form and number of course hours	Classes are held in an artist's studio, are exercises, individual adjustments, individual or team projects. In an additional hourly basis is done plein air. Number of hours per week: 8 hours.
