Aim of the course	Ability to apply the acquired knowledge to continue the educational process Openness to the diversity of artistic phenomena Willingness to pursue and develop cognitive and artistic creativity

Learning outcomes:	
– <i>knowledge</i>	- The student deepens their knowledge of drawing techniques and methods - The student expands their awareness of contemporary drawing practices
– <i>skills</i>	- The student can develop original and creative interpretations of nature - The student can create and develop a coherent artwork, exploring his/her own visual language
– <i>personal and social competence</i>	- The student is able to formulate opinions and judgements about their own works, as well as the works of other artists - The student takes an active interest in culture, as well as the cultural life and activities taking place in the academy and in the studio
Course content	Students creatively apply their knowledge and skills to produce their artworks. They consider multiple perspectives in drawing, analyse its limitations, see the difference between traditional and modern drawing. The course teaches students a variety of concepts and approaches in drawing so that the student is able to demonstrate a wide range of abilities and versatility.
Course form and number of course hours	Painting: 7 hours/week, Sculpture: 4/3 hours/week, Art Mediation: 4 hours/week Media Art: 4/3 hours/week Art and Design of Ceramics: 4 hours/week, Art and Design of Glass: 3 hours/week, Conservation and Restoration of Artworks: 3 hours/week Interior Architecture: 3 hours/week, Design: 3 hours/week Classes are held in the studio, in the form of practical tasks, individual or team projects, individual and group working critiques and consultations with the tutor, enabling students to learn to analyse and discuss their own artworks and those of their peers. (Methods: lectures, reviews or works, exhibitions)
