Aim of the course	Students continue to develop their artistic consciousness and sensitivity. Students continue to improve their drawing technique. Students develop their ability to see an artistic potential and attractiveness in things which seem not to have it.
Prerequisites	Ability to interpret any motif. Experience in using various drawing tools.
Learning outcomes:	
– knowledge	The student has an advanced knowledge of drawing techniques. The student can talk about art problems, using art terminology. The student understands the necessity to look for their own form of expression in drawing regardless of themes and motifs.
– skills	The student's drawing technique is good enough to allow them to realize any project. The student can make a sketch of any object. The student can argue in favour of his own art as well as the art of their colleagues.
– personal and social competence	The student has no problem forming his own opinions about art. The student can work in a group. The student can communicate, using the language of art and art terminology.
Course content	Students make quick sketches (that take up to 3 minutes) during the first hour of every class. Students make an advanced model study, which should exhibit artistic qualities. Students are free to choose their tools and surfaces. Students' own artistic work is the most important part of the programme in the 4th year of studies. Students practice both compositional harmony and dissonance. They prepare their own series of works and learn how to analyse their works on their own.
