

Intellectual property as a special type of legally protected property. Internal systematics of the intellectual property right. Sources of Polish law and international regulations; intellectual property right in the EU.  II. Specific issues:  II.1. Copyright: objects of copyright - catalogue and types. Works of art - with particular emphasis on artistic ceramics and glass. Holders of the copyright and related rights, along with the copyright content and protection. Transfer of copyrights and a license contract. Organizations for collective management of copyrights and related rights, Commission of Copyright, Creativity Promotion Fund. Protection of image in artistic activity. Related rights - the content of particular rights and their protection. Sui generis protection of databases.   |
